Notes on Contributors

Frauke Berndt is Professor of German Literature at the University of Zurich, after having taught at Goethe University Frankfurt am Main, the University of Chicago, and Eberhard Karls University Tübingen. She has been a visiting professor at several US-American universities. Her research on rhetoric, aesthetics, poetics and literary theory with a focus on German literature and thought spans the 18th and 19th centuries. Recently, she wrote a book entitled *Facing Poetry. Alexander Gottlieb Baumgarten's Theory of Literature* (2020). Currently she is leading the international SNSF funded research group FORM, which investigates phenomena of generic ambiguity in modern narrative fiction.

Nathan Brown is Professor of English and Canada Research Chair in Poetics at Concordia University, Montreal, where he directs the Centre for Expanded Poetics. He is the author of three books: *Baudelaire's Shadow: An Essay on Poetic Determination* (2021), *Rationalist Empiricism: A Theory of Speculative Critique* (2021), and *The Limits of Fabrication: Materials Science, Materialist Poetics* (2017). His complete translation of Baudelaire's *Les Fleurs du mal* (MaMa 2021) will be published in a new edition by Verso in 2024.

Mladen Dolar is Professor and Senior Research Fellow at the Department of Philosophy, University of Ljubljana. His principal areas of research are psychoanalysis, modern French philosophy, German idealism and art theory. He has lectured extensively at the universities in the USA and across Europe, he is the author of over hundred and fifty papers in scholarly journals and collected volumes. Apart from fourteen books in Slovene his book publications include most notably A Voice and Nothing More (MIT 2006, translated into ten languages) and Opera's Second Death (with Slavoj Žižek, Routledge 2001, also translated into several languages). His new book The Riskiest Moment is forthcoming with Duke University Press. He is one of the founders of what has become known as the 'Ljubljana Lacanian School.'

Simon Hajdini is Senior Research Associate in the Department of Philosophy at the University of Ljubljana, where he teaches social and political philosophy. He is the author of two books in Slovene and several research articles in contemporary philosophy, social and political theory, German idealism, and psychoanalysis. His book *What's That Smell? A Philosophy of the Olfactory* is forthcoming with MIT Press in 2024.

Henrik Jøker Bjerre is Associate Professor at Aalborg University. Research areas: Subjectivity, cultural philosophy, psychoanalysis, Kant and Kierkegaard. Author of: *Kantian Deeds* (Continuum 2010), *Den nyttige idiot* ("The useful idiot", Samfundslitteratur 2013), *Analysér* (Mindspace 2015), and a number of books, articles, columns and radio shows with the Center for Wild Analysis.

Peter Klepec works as Research Adviser at the Institute of Philosophy ZRC SAZU, Ljubljana, Slovenia. Main areas of research: contemporary French philosophy, German Idealism and Lacanian psychoanalysis. Author of numerous articles and essays, as well as three books (in Slovenian): *Vznik subjekta* ("On the Emergence of the Subject," ZRC 2004), *Dobičkonosne strasti. Kapitalizem in perverzija 1* ("Profitable Passions. Capitalism and Perversion 1," DTP 2008), translated in Serbian as *Kapitalizam i perverzija.* 1, *Profitabilne strasti* (Izdavačka knjižarnica Zorana Stojanovića, 2016), and *Matrice podrejanja. Kapitalizem in perverzija 2* ("Matrices of Subjection. Capitalism and Perversion 2," DTP 2019).

Bara Kolenc is a Research Fellow at the Department of Philosophy, Faculty of Arts, University of Ljubljana, and a current president of the International Hegelian Association Aufhebung. She is the author of *Repetition and Enactment* (DTP 2014, in Slovenian) and, together with other authors, a recipient of *The Highest Honor for Research Achievements in 2021 from the University of Ljubljana* for the publication *Hegel 250 – Too Late?*, *Problemi International*, 4/2020. Her book *Repetition and Subjectivity: Kierkegaard, Freud, Lacan* is currently under review with Northwestern UP.

Yuval Kremnitzer is a philosopher whose research focuses on the intersection of political ontology, culture, and technology. His book exploring the connection between the politics of the new right and the medium in which they have thrived, the internet, is forthcoming: *Unwritten no More: New Authoritarianism and the Digital Obscene* (MIT 2024).

Jamila M. H. Mascat is an Assistant Professor of Gender and Postcolonial Studies at the Department of Media and Cultural Studies at Utrecht University (The Netherlands). Her research and publications focus on Hegel and contemporary Hegelianism, Marx and Marxist Feminism, Postcolonial critique, reparations, and the uses of history. She is currently preparing a book on partisanship, provisionally entitled Don't Agonize, Organize! In praise of partisanship.

Gregor Moder is a Senior Research Associate at the Department of Philosophy of the Faculty of Arts, University of Ljubljana. He co-founded Aufhebung—International Hegelian Association and served as its first president (2014–2020). His works include *Hegel and Spinoza: Substance and Negativity* (Northwestern UP 2017), an edited volume on the *Object of Comedy* (Palgrave Macmillan 2020), and *Antigone. An Essay on Hegel's Political Philosophy* (FDV 2023, in Slovenian).

Candela Potente works at the intersection of psychoanalysis, literary theory, and philosophy. Her interests include the role of translation and transference in the epistemology of psychoanalysis, the international circulation of ideas, and philosophical debates on universality. She holds a PhD in Comparative Literature from Princeton University and serves as Postdoctoral Researcher at Aalto University.

Frances L. Restuccia is Professor of English at Boston College. She teaches contemporary theory, modernism, and the non-Western novel. She is the author of James Joyce and the Law of the Father (Yale UP); Melancholics in Love: Representing Women's Depression and Domestic Abuse (Rowman & Littlefield); Amorous Acts: Lacanian Ethics in Modernism, Film, and Queer Theory (Stanford UP); The Blue Box: Kristevan/Lacanian Readings of Contemporary Film (Continuum), and Agamben's Political Ontology of Nudity in Literature and Art (Routledge). She has published essays on Austen, Wharton, Woolf, Forster, Greene, Kundera, Sebald, Pamuk, Cha, Antoon, Gide, and Saint Augustine. She served for five years on the MLA Executive Division Committee on Psychology, Psychoanalysis, and Literature and has co-chaired the Psychoanalytic Practices seminar at the Mahindra Humanities Center at Harvard for decades. She is currently working on the psychoanalytic underpinnings of Afropessimism.

Eric L. Santner is the Philip and Ida Romberg Distinguished Service Professor in Modern Germanic Studies at the University of Chicago. He works at

the intersection of literature, philosophy, psychoanalysis, political theory, and religious thought. His books include: Friedrich Hölderlin: Nar- rative Vigilance and the Poetic Imagination (Rutgers UP 1986); Stranded Objects: Mourning, Memory, and Film in Postwar Germany (Cornell UP 1990); My Own Private Germany: Daniel Paul Schreber's Secret History of Modernity (Princeton UP 1996); On the Psychotheology of Everyday Life: Reflections on Freud and Rosenzweig (Chicago UP 2001); On Creaturely Life: Rilke, Benjamin, Sebald (Chicago UP 2006); The Neighbor: Three Inquiries in Political Theology (with Slavoj Žižek and Kenneth Reinhard; Chicago UP 2005); The Royal Remains: The People's Two Bodies and the Endgames of Sovereignty (Chicago UP 2011); The Weight of All Flesh: On the Subject-Matter of Political Economy (Oxford UP 2016); Sovereignty, Inc.: Three Inquiries in Politics and Enjoyment (with William Mazzarella, Aaron Schuster; Chicago UP 2020); Untying Things Together: Philosophy, Literature, and a Life in Theory (Chicago UP 2022).

Jure Simoniti is a researcher at the University of Ljubljana. His main research topics are truth, German idealism, philosophy of language, and philosophy of science. His latest publications include *Die Philosophie der kleinsten Prätentiösität* (Turia + Kant 2014), *The Untruth of Reality: The Unacknowledged Realism of Modern Philosophy* (Lexington Books 2016), *New Realism and Contemporary Philosophy* (co-ed. with G. Kroupa, Bloomsbury Academic 2020), and *Ideas and Idealism in Philosophy* (co-ed. with G. Kroupa, DeGruyter 2023).

Goran Vranešević is a Research Associate and Assistant Professor at the University of Ljubljana. His main areas of research include German Idealism, political philosophy, linguistics, structuralism and psychoanalysis. He has written and taught on topics ranging from aesthetics and cultural theory to classical commentaries on ontological issues and speculations on concepts. He is one of the translators of Hegel's three volumes of the *Encyclopaedia of the Philosophical Sciences* (Krtina 2020–2023) into Slovenian and editor of an edited volume *The Idea of the Good in Kant and Hegel* (forthcoming with University of Ljubljana Press in 2024).
